



# Cannonsville Critters

## FOSTER AGREEMENT

As a foster for **Cannonsville Critters**, I agree to the following rules and guidelines:

- **Michelle Hocking** and **Tom Hocking** are the owners of **Cannonsville Critters**, and I will respect their decisions on what is best for the **Cannonsville Critters** kitties. I further understand that any reference to **Cannonsville Critters**, in this agreement, is synonymous with **Michelle Hocking**.
- I will not make public, any advertisement, flyer, press release, statement, or the like, without the prior approval of **Cannonsville Critters**.
- The cat/kitten(s) is/are the property of **Cannonsville Critters**.
- If an ailment or a condition change is noted, I will contact **Michelle Hocking** via phone, email, private message, or text.
- If a cat/kitten needs to be seen by a vet, **Cannonsville Critters** will make an appointment with a **Cannonsville Critters** preferred vet. And, as the foster, I will do what I need to do, to honor the appointment.
- Potential adopters **MUST** contact and communicate with **Cannonsville Critters**, and **NOT THE FOSTER**.
- As a foster for **Cannonsville Critters**, I agree that I shall **NOT** take in any cat/kitten, on my own, as a **Cannonsville Critters** kitty. If I take in a cat/kitten, on my own, then it's care and rehoming is completely my responsibility.
- If I am fostering an unaltered kitten, I will notify **Cannonsville Critters** when the kitten has attained a weight of 2 pounds, so that **Cannonsville Critters** can make a spay/neuter appointment.
- I will make myself available to transport my foster kitties to their vet appointments.
- If I take my foster kitty to a vet of my own choosing, I will assume the costs.
- I understand, that posting **ANY** personal information on social media, and identifying myself as a **Cannonsville Critters** foster, **CAN** result in receiving certain types of harassment from potential adopters, and animal welfare "prowlers".
- I understand that there are people that stalk rescue pages to find things to critique. Therefore, anything that I wish to post, that somehow ties to **Cannonsville Critters**, must be approved by **Cannonsville Critters**.
- If I have more than one foster, or other animals, besides the foster, and **ANY** of the animals become ill, I will quarantine the sick animal(s), either in a separate room, or in a separate cage, until the illness has passed.
- I understand that the purpose of **Cannonsville Critters** is to find forever homes for the kitties in Montcalm County. Which means that **Cannonsville Critters** **MUST** do what it takes to move kitties, so as to make room to rescue more.
- To avoid confusion, if I receive a foster kitty that already has a name, I shall **NOT** rename it.
- I understand that there are **MANY** volunteers that help to keep **Cannonsville Critters** running. As a foster, I understand that if I drop the kitty at the vet, then I will be expected to pick it up. **SIMILARLY**, if I did not drop the kitty at the vet, then **I WILL NOT BE PICKING UP** from the vet. If, for some reason, I want to change that protocol, then **I WILL CONTACT CANNONSVILLE CRITTERS (I.E. MICHELLE HOCKING) TO INFORM HER.**
- **I UNDERSTAND THAT FAILURE TO FOLLOW ANY OF THESE RULES AND GUIDELINES CAN RESULT IN MY TERMINATION AS A CANNONSVILLE CRITTERS FOSTER.**
